### Minutes

February 11, 2019

All items are for discussion/possible action:

1. Call to order/Proof of Posting. The meeting was called to order at 6:30 pm by Fred Wolf. Present were Supervisors Stan Beuthin, Dan Behringer, Melody Moore and Clerk Melissa Lohre.
2. Approval of minutes: January 14, 2019. Motion to approve made by Moore, second by Beuthin. Approved 5-0.
3. Approval of January financial reports. January deposits \$465,706.15 (\$426,010.92 from tax collection). Motion to approve made by Beuthin, second by Lang. Approved 5-0.
4. Approval of February disbursements. Disbursements from general account: \$24,463.79. February settlement from tax account: \$437,150.28. Motion to approve made by Moore, second by Behringer. Approved 5-0.
5. Public Input – appreciation expressed for improvement of visibility on Hudson and Mathewson.
6. Site plan approval for Tom Vils to build a 50' x 70' building at parcel #034/0806-044-9000-2, located between Mathewson Rd and County Rd Y. Motion to approve made by Behringer, second by Beuthin. Approved 5-0.
7. Site plan approval for Andrew Brantmeyer to build a 28 x 54 house with a 22 x 24 garage at 6821 Carpenter Rd (parcel #034/0906-281-9670-0). Motion to approve made by Behringer, second by Lang. Approved 5-0.
8. Site plan approval for James LeVoy for a conditional use permit in order to build a residence at 10379 County Rd Y (parcel #034/0906-281-9040-5). Motion made by Beuthin, second by Moore. Approved 5-0.
9. Consideration and approval of mobile home park license for Rio Valley Estates, located at 10359 County Rd Y. Concerns brought up regarding drug activity at the trailer park. Will defer item to March agenda.
10. Consideration of non-binding referendum question on use of town roads for ATV/UTV use. Motion made to have a non-binding question on the April ballot "As a resident of the Township Of Mazomanie, are you in favor of ATV/UTV side by side routes within the Township, which would allow said vehicles to use township roads in much the same ways as autos, trucks, etc... Yes \_\_\_\_\_ No \_\_\_\_\_ " made by Beuthin, second by Lang. Moore registered her concern regarding the procedure of submitting the question for the ballot prior to approval by Board. Motion approved 5-0.
11. Transfer site update provided by Ron Patterson, Site Superintendent. Will use "12<sup>th</sup>" dumpster for cardboard.

13. Board Input – Lang shared March 1<sup>st</sup> meeting with Century Link to discuss two grants and USDA grant application.
